

#### VA statement regarding President Trump's executive order May 9, 2025 | VA Website

After President Trump signed an <u>executive order</u> to provide better care to Veterans, improve accountability for such care, and establish a National Center for Warrior Independence for homeless Veterans, Department of Veterans Affairs Secretary Doug Collins released the following statement:

"Under President Trump, VA is implementing a host of important reforms to improve care and benefits for our nation's heroes," said VA Secretary Doug Collins. "This executive order builds on the progress we've made so far and puts us on a path to fixing some of the department's most vexing problems.

"After decades of mismanagement, VA has been leasing parts of its 388-acre West Los Angeles VA Medical Center campus to a wealthy and exclusive private school and the University of California, Los Angeles, baseball team. Today's executive order will enable us to ensure VA's West Los Angeles Campus is being used as intended: to benefit Veterans. Our goal is to turn the campus into a beacon of hope and a destination for homeless Veterans from across the nation who can travel there to find housing and support and start their journey back to self-sufficiency.

"Under President Biden, <u>VA failed to hold its employees properly</u> accountable and actively fought congressional attempts to make it easier to fire poor-performing workers — even as health care wait times and benefits backlogs increased. With this executive order, VA will become the most accountable agency in the entire federal government. We're going to celebrate the vast majority of VA employees who do a great job every day, hold employees accountable when they fall short of the mission and work to fix the wait-time and backlog issues that developed during the Biden Administration.

"New Hampshire is the only state in the contiguous United States without a full-service VA medical center. In response to this executive order, we will develop a plan to ensure that is no longer the case."

## POW/MIA NOTIFICATIONS & PRESS RELEASES

Army Cpl. Edwin C. Martin, 18, who was killed during the Korean War, was accounted for April 29, 2025. In 1950, Martin was a member of Company A, 1st Battalion, 9th Infantry Regiment, 2nd Infantry Division. He was reported missing in action on Aug. 31, in the vicinity of Yongsan, Republic of Korea (South Korea) after his unit encountered enemy combatants attempting to cross the Naktong River. He was never reported as a prisoner of war and subsequent searches of the battlefield failed to recover his remains. With no evidence of his continued survival, the Army issued a presumptive finding of death on Dec. 31, 1953. He was declared non-recoverable on Jan 16, 1956.

Army Pvt. Mack Homer, 20, killed during World War II, was accounted for May 7, 2025. In the summer of 1944, Homer was assigned to Company E, 364th Engineer General Service Regiment, U.S. Army Corps of Engineers. On July 7, Homer was killed, along with seven other servicemembers, near Saint-Marcouf in Normandy, France, after an explosion partially caved in the concrete roof of a captured enemy bunker that they were clearing.

Army Pfc. St. Clair M. Gibson, 30, missing in action during World War II, was accounted for May 7, 2025. In September 1943, Gibson was assigned Company F, 2nd Battalion, 371st Infantry Regiment, 92d Infantry Division. He was reported missing in action on Nov. 18, 1944, after a battle in the northern Apennine Mountains near Seravezza, Italy. His remains were not recovered following the war.

Navy Ensign Joseph L. Richey, 21, killed during World War II, was accounted for on May 9, 2025. On Dec. 7, 1941, Richey was assigned to the battleship USS California, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft. The USS California sustained multiple torpedo and bomb hits, which caused it catch fire and slowly flood. The attack on the ship resulted in the deaths of 103 crewmen, including Richey.

Army Capt. Ralph L. Rowland, 43, of Santa Cruz, California, killed during World War II, was accounted for March 18, 2025. In May 1942, Rowland was assigned to Signal Company, Aircraft Warning, Philippines Department on the Bataan Peninsula, in the Philippines. He was held as a prisoner of war by Japan in the Philippines from 1942 to 1944 when the Japanese military moved POWs to Manila for transport to Japan aboard the transport ship Oryoku Maru. Unaware the allied POWs were on board, a U.S. carrier-borne aircraft attacked the Oryoku Maru, which eventually sank in Subic Bay. Rowland was then transported to Takao, Formosa, known today as Taiwan, aboard the Enoura Maru. The Japanese reported that Rowland was killed on Jan. 9, 1945, when U.S. forces sank the Enoura Maru. Rowland will be buried in Santa Cruz, California, on a date yet to be determined.

Army Pvt. Ben F. Leslie, 31, of Capitan, New Mexico, killed during World War II, was accounted for Feb. 14, 2025. In April 1942, Leslie was assigned to Battery H, 200th Coast Artillery Regiment. He was held as a prisoner of war by the Empire of Japan in the Philippines from 1942 to 1944 when the Japanese military moved POWs to Manila for transport to Japan aboard the transport ship Oryoku Maru. Unaware the allied POWs were on board, a U.S. carrier-borne aircraft attacked the Oryoku Maru, which eventually sank in Subic Bay. The Japanese government reported that Leslie died aboard the Enoura Maru on January 9, 1945. Leslie will be buried in White Oaks, New Mexico, in July 2025.


February 22, 2025 story on DPAA Family Update in Sacramento Army Air Forces 1st Lt. George F. Wilson, Jr., 22, of Bountiful, Utah, killed during World War II, was accounted for Nov. 21, 2024. In July 1944, Wilson was assigned to the 601st Bombardment Squadron, 389th Bombardment Group, 8th Air Force, in the European Theater. On July 8, Wilson, the pilot of a B-17G "Flying Fortress" bomber, was killed when his aircraft crashed near Monchy-Cayeux, France, after being hit by antiaircraft fire. Surviving crew members reported Wilson had been hit by flak and was still on board when the aircraft crashed. Wilson will be buried in Bountiful, Utah, in July 2025.

## Unlocking Veteran tax exemptions in California

- Other/Business: Honorably discharged Veterans selling goods from a fixed location may avoid municipal, county, and state business license fees (excludes alcohol sales).
- Property: Honorably discharged Veterans or their surviving spouse or pensioned parent claim a \$4,000 property tax exemption unless the property value exceeds \$5,000 (\$10,000 for married couples). Veterans with 100% disability or their unmarried surviving spouse qualify for a larger exemption with basic and low-income tiers—check with the local assessor.

## Action Corps Weekly

VFW Meets with House Committee Chairman: VFW Washington Office Executive Director Ryan Gallucci and National Legislative Director Kristina Keenan met with House Committee on Veterans' Affairs Chairman Mike Bost to discuss the VFW's legislative priorities and our call to Honor the Contract to ensure that veterans receive the benefits they have earned and deserve as promised in military service contracts. They expressed support for bills introduced by the chairman, such as H.R. 740, Veterans' ACCESS Act of 2025, and H.R. 1041, Veterans 2nd Amendment Protection Act. The VFW looks forward to continuing work with Chairman Bost on these proposals and other important pieces of veteran legislation during the 119th Congress.

Senate Hearing on Future at VA: The Senate Committee on Veterans' Affairs held an oversight hearing with Secretary Douglas Collins on the future at VA. Collins emphasized the need for reforms to better provide health care and benefits to veterans, and confirmed his commitment to reduce wasteful spending. He stated he would keep mission-essential jobs and phase out nonessential roles with the goal of a 15 percent reduction, and work to eliminate inefficiencies to reduce appointment wait times and the number of pending claims. ## DISABLED AMERICAN VETERANS CHAPTER 118

H.R. 1860, the Women Veterans Cancer Care Coordination Act, would mandate the appointment of regional breast and gynecologic cancer care coordinators within each Veteran Integrated Services Network (VISN). These coordinators would be responsible for ensuring seamless communication and coordination between Department of Veterans Affairs (VA) clinicians and cancer community care providers.

This regional approach aims to provide tailored support, ensuring that veterans receive timely and appropriate care regardless of their location while monitoring services provided, tracking health outcomes and maintaining data on cancer care. This data-driven approach would help to identify trends, measure effectiveness of services and guide future improvements in care delivery.

We support H.R. 1860 in accordance with DAV Resolution No. 39, which calls for the VA to provide gender-tailored health care and specialized services to women veterans.

We call on DAV members and supporters to contact their representative and urge them to co-sponsor and support H.R. 1860. As always, we appreciate your support for DAV's legislative priorities

Many service-disabled veterans face challenges when transitioning to civilian life, particularly in securing stable and meaningful employment. Despite possessing valuable skills and experiences gained through military service, these individuals often encounter barriers such as personal qualification requirements and a lack of opportunities that align with their expertise.

H.R. 1242, the Hire Veterans Act, would address these challenges by creating a 5-year pilot program which would dedicate a pathway for service-disabled veterans to access employment within federal land management agencies. It would recognize the unique strengths and skill sets service-disabled veterans bring to the workforce that align with the needs of the National Park, Wildlife and Fish agencies.

We support H.R. 1242, the Hire Veterans Act in accordance with DAV Resolution No. 238, which supports identifying, reducing and removing barriers to a service-disabled veteran's employment.

Please contact your representative and urge them to cosponsor and support this important legislation. Thank you for your support and advocacy for service-disabled veterans, their families, caregivers and survivors.



## Original Memorial Day Order

Headquarters Grand Army of the Republic, Washington, D.C., May 5, 1868.

GENERAL ORDERS No. 11

I. The 30th day of May, 1868 is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village, and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances may permit.

We are organized, comrades, as our regulations tell us, for the purpose, among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors and marines who united to suppress the late rebellion." What can aid more to assure this result than by cherishing tenderly the memory of our heroic dead who made their breasts a barricade between our country and its foes? Their soldier lives were the reveille of freedom to a race in chains and their deaths the tattoo of rebellious tyranny in arms. We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders. Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and fond mourners. Let no vandalism of avarice or neglect, no ravages of time, testify to the present or to the coming generations that we have forgotten, as a people, the cost of a free and undivided republic.

If other eyes grow dull and other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remains in us.

Let us, then, at the time appointed, gather around their sacred remains and garland the passionless mounds above them with choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us as sacred charges upon the nation's gratitude—the soldier's and sailor's widow and orphan.

II. It is the purpose of the commander in chief to inaugurate this observance with the hope that it will be kept up from year to year, while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to call attention to this order and lend its friendly aid in bringing it to the notice of comrades in all parts of the country in time for simultaneous compliance therewith.

III. Department commanders will use every effort to make this order effective.

## **MEMORIAL DAY**

## History of Taps

The creation of our country's most revered bugle call has been credited for many years to General Daniel Butterfield, commander of the Third Brigade, First Division, Fifth Army Corps of the Army of the Potomac during the Civil War.

It was believed that the general wrote the call in July 1862 while his brigade was camped in Confederate territory at Harrison's Landing on the banks of the James River in Virginia following the Seven Days Battle. Brigade bugler, Oliver W. Norton, first sounded the call there.

Years later, in 1898, Norton wrote about the creation and première of "Taps." He claimed that General Butterfield showed him some notes on a staff written in pencil on the back of an envelope and asked him to play them. General Butterfield made some revisions to the music and instructed Norton to sound this call in place of "Lights Out" that evening.

General Butterfield wrote in response to this that Norton's recollection was generally correct. He stated that he was knowledgeable of military bugle calls and could sound them himself. "Lights Out" did not seem as smooth, melodious, and musical as it should be, so he called upon some one who could write music to make the changes in the call (he claimed to be unable to read or write music).

Recently scholars have discovered that General Butterfield did not compose this new call but revised an earlier call with which he was familiar. The origin of that call which the General gave to Norton was found in an early version of "Tattoo" and was published in at least three drill and tactics manuals: the Winfield Scott manual of 1835, the Samuel Cooper manual of 1836, and the William Gilham manual of 1861.

The last five measures of the version of "Tattoo" very closely resemble the current day "Taps." Undoubtedly, General Butterfield was remembering this earlier call he had learned from his previous training as a regimental commander. He made revisions to it to suit him and had Norton sound the call. The new call spread quickly to other units in both the Union and Confederate armies. It began to be used for funeral ceremonies almost immediately, but it was not until 1891 that U.S. Army drill regulations made it mandatory for funerals.

## Memorial Day Flag Protocol

Flag etiquette on Memorial Day is unique. At sunrise, flags are to be raised to full staff briskly, then lowered to half-staff position where they will remain until noon. If you are unsure how to properly lower your flag to half-staff, watch this short how-to video (see link below).

At noon, flags are to be raised to full-staff and will be displayed there for the remainder of the holiday. If you are unable to display the flag at half-staff on Memorial Day, proper flag etiquette requires that you display your flag with a black mourning ribbon to show respect and acknowledge the somber meaning of the day.



## Congressional Medal of Honor To Specialist Five Dennis M. Fujii

"Specialist Five Dennis M. Fujii distinguished himself by conspicuous gallantry and intrepidity beyond the call of duty while serving as crew chief aboard a helicopter ambulance during rescue operations in Laos, Republic of Vietnam, during the period of 18 to 22 February 1971. Specialist Five Fujii was serving with the 237th Medical Detachment, 61st Medical Battalion, 67th Medical Group. The team's mission was to evacuate seriously wounded Vietnamese military personnel from the midst of a raging battlefield. The aircraft's primary approach to the bullet-infested landing zone was thwarted by heavy volumes of enemy fire directed at the specialist's helicopter. As the pilot made a second landing attempt, the enemy concentrated a barrage of flak at the air ambulance which damaged the craft and caused it to crash in the conflict area, injuring Specialist Five Fujii. Moments later, another American helicopter successfully landed near the wreckage of the specialist's airship and extracted all the downed crewmen except for Specialist Five Fujii, who was unable to board due to the intense enemy fire directed at him. Rather than further endanger the lives of his comrades aboard the second helicopter, Specialist Five Fujii waved the craft out of the combat area and remained behind as the only American on the battlefield. Subsequent attempts to rescue the specialist were aborted due to the violent antiaircraft fire. Specialist Five Fujii finally secured a radio and informed the aviators in the area that the landing zone was too hot for further evacuation attempts. During the night and all through the next day, Specialist Five Fujii disregarded his own wounds as he administered first aid to the allied casualties. On the night of 19 February, the allied perimeter came under ruthless assault by a reinforced enemy regiment supported by heavy artillery. Once again obtaining a radio transmitter, Specialist Five Fujii called in American helicopter gunships to assist the small unit in repelling the attack. For a period of over seventeen consecutive hours, Specialist Five Fujii repeatedly exposed himself to hostile fire as he left the security of his entrenchment to better observe enemy troop positions and to direct air strikes against them. At times the fighting became so vicious that Specialist Five Fujii was forced to interrupt radio transmittal in order to place suppressive rifle fire on the enemy while at close quarters. Though wounded and severely fatigued by 20 February, the specialist bore the responsibility for the protection and defense of the friendly encampment until an American helicopter could land and attempt to airlift him from the area. As his air ambulance left the battlefield, it received numerous hits and was forced to crash land at another South Vietnamese Ranger base approximately four kilometers from the specialist's original location. The totally exhausted Specialist Five Fujii remained at the allied camp for two more days until yet another helicopter could return him to Phau Bai for medical assistance on 22 February. Specialist Five Fujii's extraordinary heroism and devotion to duty were in keeping with the highest traditions of military service and reflect great credit upon himself, his unit, and the United States Army."
